AN ORDINANCE AMENDING SANTA CLARA COUNTY CENTRAL FIRE PROTECTION ORDINANCE NO. CFPD-2015-1, AS AMENDED BY ORDINANCE NO. CFPD-2015-2, ORDINANCE NO. CFPD-2016-1 AND ORDINANCE NO. CFPD-2016-2, RELATING TO THE COMPENSATION OF EMPLOYEES


